- BYLAWS COMMITTEE – meets when necessary to review and change current bylaws of SVAR.
- AWARDS COMMITTEE - This committee reviews nominations for the Awards and chooses the best recipients for the Awards. They meet only 2 times per year.
- GOVERNMENTAL AFFAIRS COMMITTEE – This committee attends legislative functions on behalf of SVAR and works with our area legislators for homeownership rights.
- GRIEVANCE COMMITTEE – meets as needed to review complaints filed by members or the public. Committee members will be required to attend yearly training in Rockford once a year to keep updated.
- PROFESSIONAL STANDARDS COMMITTEE - meets as needed by the Illinois Association of REALTORS® for hearings on complaints filed and forwarded by the Grievance Committee. Committee members will be required to attend yearly training in Rockford once a year to keep updated.
- MULTIPLE LISTING SERVICE COMMITTEE - This committee meets about 10 times per year and focuses on MLS issues, complaints and looks for new Technology and MLS Vendors as needed. They set the MLS Rules and make recommended changes to the Directors.
- PUBLIC RELATIONS COMMITTEE - This committee meets about 9 times per year and they focus on making sure the Association stays in front of the Public's eyes by donating their time and monies (Association moneys) to needy entities.
- MEMBERSHIP/EDUCATION COMMITTEE - This committee meets 2 times per year and they organize the membership meetings and continuing education events. This committee also reviews applications for members and recommends to the directors for approval of membership.
- BUDGET COMMITTEE - This committee meets 1 time per year and makes a recommended budget each year for the directors to approve and present to the membership.
- EQUAL OPPORTUNITY - educates the members and the community on Fair Housing and the real estate industry.
- FORMS COMMITTEE – This committee meets as needed to review the current forms of the Association and makes recommendations for necessary changes to them or the creation of new forms if necessary.
- NOMINATING COMMITTEE – This committee meets to review candidates for the Board of Directors and Officers and makes recommendation via the Slate of Officers and Directors to the membership.
